## **Brexit a good opportunity to unlock new markets**

Brexit presents a good opportunity for farmers and producers of dairy products in the UK to unlock new markets, according to a report on the future of dairy exports published by Dairy UK in November 2016. The report, which explores the potential impacts of leaving the EU, has revealed that 80% of dairy exports from the UK go to EU countries. As a result, Dairy UK argues that continued access to the single market is crucial to the future success of the dairy sector.

The report has also indicated that the total volume of UK dairy exports to both EU and non-EU countries increased by 91% from 2011 to 2016. Consequently, Dairy UK believes that the Government should also prioritise negotiating new free trade agreements to help dairy farmers grow their business through exports to new and emerging markets.

## Landowners to be paid less for phone masts on their land

Under the new legislation, landowners will no longer receive a rental fee based on the land's market value. Instead, they will be paid compensation depending on the amount of land occupied by the phone mast, regardless of what the land was to be used for or its value.

## Farmers turn to second-hand market for machinery

Farmers are increasingly choosing to invest in second-hand stock instead of purchasing new machinery, according to research by the Agricultural Engineers Association. The research has revealed that registrations of new tractors fell by 11% from 2015 to 2016, while sales of second-hand stock increased significantly over the same period.

## Organic food sector performing strongly

Supermarket sales of all types of organic products increased by 6% in the 12 months to October 2016, according to figures published by Nielsen. In comparison, sales of non-organic products fell by 0.7% over the same period. The figures have revealed that sales of organic food produce, particularly fruit, recorded the strongest growth, up 9.6%. According to research by Soil Association Certification, an increase in the number of consumers who actively search for products with credible and audited supply chains is one of the main reasons for growth in the organic food sector. The research has also indicated that growing consumer awareness and interest in food production practices is also boosting demand for organic produce.
